Lakes

The lakes were treated for algae in July and the cattails were removed as requested by the homeowners on Lake H. Dye was applied to the lakes again on August 14, 2013. The city of Issaquah sent a letter requesting some cleanup around the lakes. Jay Willenberg and Don Hermanson met with the City Engineer and convinced the city to leave the sandbags where they are for now. Doug at Northwest Aquatic Ecosystems will be cleaning up the other issues raised by the city, including re-grouting the grate of the Lake F vault. The estimated cost of the repairs to the Lake F vault is \$2,500, which is to be charged to capital expenses. All fountains are operating normally.

Waterfalls

The lights on the small waterfall are still out. I notified WE Electric weeks ago, but they have not yet corrected the matter. I sent them another email again today. There are still a few minor issues with the wireless waterfall monitoring system. For some reason we are able to remotely monitor water usage on the small falls, but not the large falls (even though the instruments are identical). So until this situation is resolved, we will have to rely on manual readings of the water meter that feeds the large falls. During the last 2 months (August and September) the waterfalls have used a total of 9,516 gallons of water, which works out to an average of \$28.55 per month or about 95 cents per day. We have had several soapings during the last couple of months, so the water quality is pretty poor at this time (note brown color in photo below). At my request, Signature Landscaping has removed all of the floating plants that I mentioned in the last meeting. No one seems to know the origin of those plants. The water in both falls was treated with a copper based algaecide in mid-September.
