#### LANDSCAPING

Myrt provided the following landscaping updates:

- There was a complaint about an irrigation leak in a valve box on Montreux Dr. The homeowner thought it was the central system causing the leak, however it turns out it was the homeowner's.
- The Board has made reasonable, however unsuccessful, attempts to collect reimbursement from two drivers
  who knocked down two of the trees along VPD. The Board reviewed the costs and benefits and decided not
  to proceed with small claims court. At some point, the Board will need to decide whether or not to replace
  the trees.
- Myrt has done many drive-thrus with the landscaping supervisor to assess what work needs to be done.
- They will be trying to determine if any of the green utility boxes are viable. If they are not viable, then they will be removed.
- The bollards in front of the lake on Lac Leman and Oberland Dr were replaced.

#### PONDS AND WATERFALL

Jerry provided an update on the ponds and waterfalls. The waterfalls have been cleaned and are in good working order. We are using more water in the waterfalls due to the hot summer. Jerry is going to talk to Jake about covering the spigot near the main waterfall.

A pump is out in one of the ponds. There will be a third attempt to repair the pump on Saturday (repairs are under warranty). If it doesn't work, we may need to replace the pump which will not be covered under the warranty. Cost is tbd.

#### WEBSITE

Charlie did a recent clean-up of the website. Website usage is slowly increasing, especially the email notifications. Charlie will put a link to the condo association in the FAQs to hopefully deflect some of the condo-related questions the Board receives.
