Mark will get a bid from a painting firm he knows to paint all of the mailbox structures in the neighborhood. He will also get a bid for repainting of the monuments.

Phil asked about the Board's rights to act on homes with deteriorating landscaping. Jay noted that the CC&Rs give us the right to perform landscaping to bring it up to par with the rest of the neighborhood and bill the homeowners.

TREASURER

Jay gave a financial update. We do have some delinquent homeowners, but the list has not materially changed over the past year. Jay walked through the process he and Rosemary go through to notify delinquent homeowners.

SECRETARY

Leslie reported that she sent invitations to the neighborhood distribution list for the Montreux Nextdoor website. So far about 70 people have joined.

She has also put together a sample "New Homeowner Package". Her thoughts are to get a mass quantity printed and then to have Rosemary send them out to new residents with their first quarterly billing. She will also mail them to new homeowners as of the past year or so.

NGPE

John reported there have been a few tree issues. He noted that since the issue on the Gilman property, the City Enforcement Officer has been out monitoring the NGPE.

LANDSCAPING

Bob A provided the following landscaping update:

- Sprinklers have needed some repairs, but not beyond a normal amount. The time the water has been on has been increased as well as the frequency. A few Board members noted that it appeared we didn't have nearly as much sprinkler water run-off as in previous years.
- He has been out doing walkthroughs with Mark at NLS and they have been really responsive when there are issues.
- Alder trees by Alpen Glow have been hacked.
- We have lost some of the arbivatae that were replaced; however, they are still under warranty.
- We replaced some trees along VPD; however, we have lost some additional trees. We should have a plan to replace ~10 trees per year.
- He should be receiving a proposal from NLS to replace the irrigation between Div 3/Lot 24 and the condominiums.

Marilyn asked a question about whose responsibility it is to repaint the fire hydrants and standpipes. She thinks a few years ago the City was called and they came out to paint. Marilyn will contact the City to see if they will do it again.

PONDS AND WATERFALL

Jerry reported the waterfalls have been cleaned. No sand was found at the bottom to potentially clog the lower pond pump.

Lights on the trees have been on nearly 24/7. Jerry will contact Jake at WE Electric.

Jay reported City Inspector found a few years ago that the lakes are not truly connected to each other like we initially though. We have pump on the top lake, but the other two are all run-off water.

Ali reported the Block Party will be September 12th from 4:00-7:00. She passed around a volunteer list. Leslie will send out an Evite, post a notification on Nextdoor, and send out an email.
