- They will also start doing moss control in the grassy areas

TREASURER

Jay provided a brief financial update. We are only a month into the fiscal year, so the budget is doing well. While Rosemary is officially retired, she will be available to help during our annual financial statement review.

ELECTRICAL

Ken and John provided the following lighting updates:

- There are 75 tree lights throughout the neighborhood
 - Ken has done a daytime and nighttime inspection of every light to determine their working condition
 - Of the 75, 21 lights were on and working, 21 were broken, 30 needed new bulbs
 - WE Electric came out and replaced the 30 which needed new bulbs
 - o After they were replaced, 24 again went out
 - o 19 of them had water in them
- About 30% of the mailbox structure lights are out
- Ken and John met with Jake from WE electric last night
 - Ken asked to receive a detailed report for each light to see which fixtures need to be replaced

- Lights are currently in a square enclosure and have been damaged by roots
- Water is coming in through the bottom of the fixtures and shorting out the lights
- It won't do us any good to install LED bulbs until the fixtures are fixed or replaced
- Ken wants WE Electric to first meet their contractual obligations and get the lights in working condition, then the Board can determine whether or not to continue their contract

NEIGHBORHOOD IMPROVEMENTS/MAINTENANCE COMMITTEE

Ken and John also reported on the following items their committee came up with for neighborhood improvements / maintenance:

- Items that require expenditures:
 - o Power wash/repaint monuments and mailbox wooden structures
 - Install three wooden benches on VPD, set back from the road met with City Planning Dept and they approved the three locations (estimated cost: \$800 each)
 - Look at the possibility of community park(s) met with City Planning Dept. They are not opposed to us using NGPE land. Park would be at our expense and our responsibility for maintenance and liability. They would need to approve location(s).
 - o Lights on Village Park Dr
 - Replace (5) broken and (10-12) leaking in-ground light fixtures that are not repairable (estimated cost: \$400 each)
 - Rewire corroded wiring to sockets
 - Provide sockets for seasonal lighting at monuments
 - Extend lighting to the set back pathway use solar to minimize wiring
 - Possibly replace grass strips between trees on VPD with shrubs. Less maintenance and water usage.
- Items with no costs:
 - More active CC&R enforcement of homeowners' front yards where shrubs are overgrown, trees need pruning and lawns not being maintained. Define yard standards.
 - o Community Events Trash collecting day once a quarter, power wash sidewalks
 - Provide tips and hints in the newsletter
 - o Sidewalks (City responsibility), but discuss root grinding with the City
