COVID-19

Issaquah is following a phased opening like all of King County. As a City we are here to implement the standards that come from King County and the Governors' office. Currently seeing an increase in numbers which concerns us.

We are committed to engaging the Community via a volunteer TaskForce http://issaquahwa.gov/3211/Recovery-Task-Force. This advises the Administration on various issues relating to COVID-19. You're able to join the meetings or watch the recordings on YouTube http://youtube.com/cityofissaquah

We piloted the Streatery program to help restaurants open but outdoors on a pedestrian only Front Street. Currently collecting feedback on the process to decide the next steps.

Some residents are struggling as they're not able to work and therefore not able to pay rent. We've delivered some rent relief for personal and business tenants.

Mayor and Council members are frequently being asked what community members can do to help. One suggestion: the <u>Issaquah Food and Clothing bank</u> cannot accept drop offs, but they can accept donations delivered straight from the supplier, and monetary donations.

Recently there was a 500 person peaceful demonstration down Issaquah Front Street.

Question: Asking about overnight parking – noticed that there's a mobile home using car parks around Issaquah. Is this legal?

Answer: We do not have an active and engaged program to help people who are living outside in Issaquah. We want to be able to address those that are living in crisis.

Question: What is the plan for opening the Issaquah School District?

Answer: The Issaquah School District is bigger than just Issaquah. They have a Board meeting that we are able to watch on Thursday 9th 6pm https://issaquah.wednet.edu/board They have pivoted the content from discussing how to make sure students are served during lockdown to planning for what September might look like.

Question: Is there a law against operating a business from your house?

Answer: Yes, it's allowed, but there are regulations that are needed to be followed. Please connect with Autumn Monahan to follow up

Question: Our property taxes have been increasing by around 10% year over year and the inflation is below 2%. What are we doing to control cost?

Answer: The City's portion of the bill is capped at a maximum 1% increase. Recent increase have been based on voter approved initiatives.

Question: With all the construction which took place along Newport way, who is responsible for maintaining all the planting beds/islands?

Answer: Probably a combination of the City Parks Department and the developer

3. Treasurer's report

Budget was passed as no one objected to the budget via the ballot.

Question: Can we pay community fees online in the near future:

Answer: We will look into it

Question: What are we doing to collect delinquent dues?

Answer: We have followed up with some bad debt and they are paying twice as much each

quarter. For very bad payers we are considering legal action

Question: What happens if more money is needed when we move forward to fix things like dead trees?

Answer: Jay Willenberg stated: I consider replacing dead trees as a Capital Expense, much like fixing the pumps on the waterfalls or doing major repairs on the irrigation system, because trees are expected to last more than a few years. The with the Board's approval the money set-aside in the Capital Expense fund should cover the needs to replace trees that must be replaced this year. As the Landscape Committee develops their 5 Year Plan, we will see if there will be a need for a dues increase. Also, Article 9 of the CC&Rs in part says:

"The Board may revise the budget from time to time as deemed necessary or advisable to account for and defray additional costs or expenses of the Association. Upon adoption of a budget, the Board shall assess all Lots with general and/or special assessments as provided in this Declaration."

Answer: Jerry covered this question in his presentation. Getting a security camera is on the "wish list" of things to be able to monitor for vandalism.

Question: On neighborhood walks, there are many properties that have shrubs that come out into the sidewalk, making it difficult to pass. Can we address this?

Answer: Yes, we are seeing people sprucing up their properties already but plan to address this.
