- Replanted 72 (8-foot arborvitae)
- Added organic soil
- Assessed reasons for not thriving
- Plan to replant 34 more in April

  - 11 Controllers,
  - 118 Zones,
  - 2,146 Heads
- Sprinkler heads were uncovered; Maintenance recommendations documented.
- Include in the Reserve Study for multiyear funding.
- 2021: Prioritize repair activity based on potential for wasted water.


