




Irrigation System

- Record-setting heat wave in June 2021.
- Second longest dry spell on record this summer.
- Repairs authorized for Controller 3 and 4 this spring were started this fall.




Significant tree root impact on irrigation






Irrigation System

Montreux Waterfalls

The waterfalls used 69,492 gallons of water in September 2021 (2" rain) compared to 70,101 gal. in August 2021 (1/4" rain)

The water bill for July through mid-September was \$261.16 which works out to \$3.43/day. Electricity cost: \$29/day

Both falls are working fine, but the main light that shines on the top portion of the large falls is not working at night.
