

Late Fees and Interest

- On April 14, 2020, in response to the COVID-19 pandemic, Governor Inslee issued Proclamation 20-51: Community Association and Late Fees. This proclamation prohibited homeowners' associations from charging interest and fees for late payment of assessments while the Proclamation was in effect.
- Governor Inslee rescinded this Proclamation starting July 24, 2021.
- The HOA resumed charging interest and late fees for overdue accounts effective August 1, 2021.
- As of October 23, seven homeowners have overdue accounts totaling \$8,613
 with \$472 more in late fees and interest since August 1.



Montreux HOA Board Meeting November 10, 2021

Waterfalls

The waterfalls shut down automatically on October 16 due to a low water level alarm. It turns out that someone shut off the makeup water supply at the irrigation water supply meter that serves the waterfalls. Jake, from WE Electric, was able to locate and open the shut-off valve to keep the falls running. No one knows who could have shut off the water supply.

The outdoor light that shines on the top of the falls is full of water and not functioning. Jake, from WE Electric, is ordering up a new light fixture.

The waterfalls used 69,492 gallons of water in September and 49,248 gallons in October 2021 (with a total of 10.87 inches of rain), compared to 175,746 gallons in July & August 2021 (with only 0.32 inch of rain).

Our water bill for both waterfalls for the 61 day billing period for July 1 through September 14, 2021 was \$261.17 which works out to \$3.53/day.

The electric bill for September was \$906.08 (\$30.20/day), up 6% from the August bill of \$852.60. The increase is probably due to longer hours for nighttime lighting.

Recent inquiry regarding HOA allowing satellite dishes to be visible CC&Rs (1991) Para 5.13 states, in part, that antennae including satellite dishes are prohibited unless screened from view.

In 1996, the FCC adopted by direction from Congress, a rule that prohibits restrictions that impair the installation, maintenance, or use of antennas or satellite dishes. The rule prohibits most restrictions that prevent/preclude acceptable reception of a signal.


- There are only a few satellite dishes on Montreux homes.
 One is located on upper roof, backside of the house (not very visible).
 Another one is on the side of the house which is exposed on all four sides (there is no option for hiding/screening).
- In the above cases, the HOA believes the locations are protected by the intent of the FCC rule.
- To avoid confusion in the future, the HOA should consider amending the CC&Rs to be compliant with the FCC rule.



Native Growth Protection (NGPE) Report

- Arborwell Tree Company completed the contract work to remove high risk trees in the NGPE.
- Additional hazardous trees have been identified and will be discussed in the near future for addition to the NGPE work program.
- The City continues to work internally to resolve the NGPE designation on the original plat drawings for the retention ponds. The City agrees that we should continue to maintain our ponds the way we have done for the past 25+ years.
