President's Report

Background

The Issaquah Police Department is actively exploring the deployment of Flock license plate reader (LPR) cameras to enhance public safety, particularly in response to a significant rise in property crimes and retail theft throughout the city. On February 25, 2025, Chief Paula Schwan presented the City's initial Flock proposal to the City Council Services, Safety & Parks Committee.

City's Position and Objectives

- From 2016 to 2022, Issaguah experienced a:
 - 42% increase in property crimes
 - 60% increase in larceny thefts
- The Issaquah Police Department believes Flock cameras can:
 - Aid in suspect identification
 - Improve officer response time
 - · Support faster case resolution
 - · Enhance overall public and property safety
- Issaquah PD is currently gathering feedback from stakeholders and intends to present a full proposal for consideration by Spring 2025.

Potential Cost (Per City Proposal)

| Camera Type | Install Cost | Annual Lease |
|-------------------------|--------------|--------------|
| Falcon (2-lane roads) | \$3,650 | \$3,000 |
| Long-Range (4-lane) | \$5,650 | \$5,000 |
| Replacement (if stolen) | \$800 | N/A |

President's Report

- We recently received a letter from Lt. Alex Helms (Issaquah PD) stating the department is requesting federal grant
 funding to support this effort. While this was not confirmed in the public council meeting materials, it may indicate a
 developing funding strategy.
- There is currently no indication that the City will cover HOA-related Flock installations, though collaboration may be possible in the future.

Conversation with Lakemont HOA

I spoke with John Beringer, President of the Lakemont HOA, who confirmed that their board is currently still evaluating the Flock system and bringing it to their homeowners for consideration. They have not yet made a decision and are in the process of gathering feedback from their members.

This reflects a shared sense of caution and diligence in decision-making and suggests other HOAs are in a similar stage of consideration.

Next Steps for Our Board

- 1. Review the proposal and costs as outlined above.
- 2. Decide if we want to support the City's grant application.
- 3.If supportive, determine the feasibility of funding (dues increase, reserve allocation, or special assessment).
- 4. Consider creating a policy around data retention, access, and law enforcement sharing, should we proceed.






