## **Key Liability Scenarios for HOAs**

- Installation on HOA Property:
  - Premises liability (hazards, vandalism)
  - May require indemnity or insurance
- Camera Placement Disputes:
  - Privacy complaints near driveways/courts
- Data Usage Misunderstandings:
  - Residents may assume HOA has access

## **Lakemont HOA – Flock Review Status – July 2025**

- No formal decision made on Flock cameras
- Very low meeting attendance (~23 attendees, 11 households)
  - Broader safety discussed, not just Flock
  - HOA is in a wait-and-see posture due to liability concerns

- City of Issaquah has requested a meeting. The Native Growth is owned and maintained by the Montreux HOA. However, the City has the authority to approve or prohibit pruning and/or clearing in the NGPEs. "The cost of maintenance of vegetation management shall be assessed against owners or rim lots in Divisions 1 and 3." Champery is located in Division 4.
- 6.2.7-The maintenance of the lakes shall be the duty of the Association. The Association shall fulfill all duties and pay all expenses in connection with maintenance of the lakes and detention facilities.
